Notes for Handlers

- 1 **Running Order:** By mutual agreement, owners/handlers may exchange their order of running, subject to the approval of the Stake Manager, confirmed by the Judge.
- 2 **Late Withdrawals:** If, for any reason, owners have to withdraw their hounds from Working Trials, they should notify the Stake Manager
3. **Runners:** Unless otherwise instructed, all runners will remain at the end of their lines for the following minimum periods (from the time the hound started the line).
Novice Stake = ¾ hour
Junior Stake = 1 ¼ hours
Intermediate Stake = 1 ¾ hours
Senior Stake = 2 hours
4. **Handlers:** Are requested to wear '**White**' to aid visual identification by spectators and followers.

5. Anyone wishing to follow a hound should ask permission of the Judge and the Stake Manager.

It is important to keep well behind the Judge and Assistants at all times.

6. Competitors who are unable to attend the summing up and prize giving should make their apologies known to the judge in person.

Notes for all attending Bloodhound Working Trials:

1. **The Working Trials are held by courtesy of the local Landowners and Farmers. Any request made by them that hounds should be hunted leashed, regardless of the fact that they have a full permit, will be strictly adhered to. The stake manager and / or the judge are responsible for ensuring that competitors are made aware of any local arrangements.**
All competitors and spectators are reminded of the importance of closing gates and the necessity of safeguarding farm stock and wild animals.
2. **For your hound's safety and that of other road users:** The A.B.B. recommends that hounds are suitably restrained and confined in vehicles behind a dog guard or cage. Windows may be open providing there is no risk to pedestrians and other road users.
Hounds must be exercised on a leash.
The A.B.B. will not be responsible for any injury or compensation occasioned by, or arising out of, this Working Trial.
3. **Car Drivers:** Are requested to aid other vehicles and drivers in the Working Trials area. Please avoid giving hindrance to other road users not connected with the Working Trials.
Do not enter or park vehicles in farm driveways unless instructed to do so by the Stake Manager
4. **Late Arrivals:** May have difficulty in finding the party and are advised to make their own arrangements to be met; instructions will be left at the 'Meet' each day.
5. **Road Crossings:** No-one (cars included) is allowed **within thirty metres** of the indicated crossing position, until the hound and handler have progressed.
6. **All Cups & Trophies:** If awarded, are to stay within the United Kingdom, exceptions indicated.
7. **First Aid Kit:** Held by the Stake Manager
Any member who is dis-satisfied with the organisation of the Trials should make their complaint to the Hon. Trials Secretary before the end of the Trials.
